RULES AND REGULATIONS OF SHRI. PARAMHANSA RAMKRISHNA
MAUNIBABA SHIKSHAN SANSTHA, CHIKHLI. (DIST.-BULDANA)

1. Jurisdiction

Jurisdiction of the Society shall be over the Maharashtra State.

a) Founder Members - The persons those whose names have been mentioned in the enclosed list shall be the founder members of the Society. They shall have to pay an Annual Subscription of Rs. 101/- every year. If any vacancy will occur in the founder members, it shall be filled in by simple majority of votes by the remaining founder members.

b) Ordinary Members - For becoming member of society in future such interested person shall have to apply to the Governing Body for Membership. It shall be the absolute discretion of the Governing Body to accept or reject such application. The Governing Body shall not be bound to disclose any reason. Such members shall be an ordinary members of the society. He will have to pay an annual Subscription of Rs. 52/-. He shall have a right to vote but shall have no right to contest the Election of the Governing Body.

3. Governing Body & its Formation

The Governing Body shall consist of 7 members out of whom one shall be president, one Vice-President, One Secretary, one treasurer and other three members.

4. Period of the Governing Body

The period of the Governing Body shall be of 5 years, and after every 5 years new managing Committee shall be elected in the meeting of the General Body. The members so elected shall elect President, Vice-President and Secretary and Treasurer among themselves. If there is any vacancy during the tenure of the Governing Body then it shall be filled in by the members of the Governing Body.

5. Period of the Governing Body

All the properties of the Society shall vest in the Governing Body, and Governing Body shall have power to purchase the property for the Society or to transfer the same by way of sale, exchange, gift etc. subject to the Provision of the prevailing enactments.

- a) To appoint, to remove and to punish the staff and Servants required for the society and to fix their salaries.
- b) To accept or reject the application for memberships.
- c) if any members acts against the interest of the Society or if any member does not pay the annual subscription, inspite of the notice, then the Governing Body shall have the power to remove such members from the society by passing the Resolution by 2/3rd majority of the members present in the meeting.

6. Duties and Powers of the Office bearers -

- a) **President** shall preside over all the meeting of the society and he shall have direct the Secretary to convey the meeting of Governing Body, and general body. He shall also look after the day to day affairs of the Society. The President shall have power to operate the Bank accounts alongwith the Joint signatures of Secretary or Vice President.
- b) **Vice-President** : He shall assist the President in his day to day work. He can operate the Bank accounts along with the Joint signatures of the President.
- d) **Secretary** : Secretary shall issue notices for all the meetings as per directions of the President and shall maintain day to day accounts of the Society and shall also look after the correspondence of the Society. Secretary can also powers to operate the Bank Accounts with the President.
- e) **Treasurer** : shall have power to check the accounts.

7. Meeting of the Governing Body -

The meeting of the Governing Body shall be held at least once in a six months. For such meeting, 7 days notices shall be issued. The notice shall be circulated to the members and if any member is not available for signatures, or refuse to receive the notice then it shall be sent under certificate of posting and such notice shall be deemed proper, quorum for the meeting of the Governing Body shall be one half, and if no quorum is assembled at the schedule time, then the meeting shall be adjourned for half an hour and no quorum shall be required for such adjourned meeting.

In emergency Meeting of the Governing Body may be called by 24 hours notice. The President may

also call a meeting of the Governing Body whenever required and such meeting shall be called a special meeting.

8. Meeting of the General Body

The meeting of the General Body shall be held once in a year. 10 Days Notices shall be issued for such meeting through notice board, if any member is not available for signature, or refuse to receive the notice, then it shall be sent under the certificates of posting and such notice shall be deemed to be proper notice. One third of the total numbers of the members shall form quorum for such meeting and if no quorum is available, then the meeting shall be adjourned for half an hour, and no quorum shall be required for such adjourned meeting.

9. Business of the General Body

The General body shall consider the income and expenditure of the last year and give sanction to the budget at the current year placed by the Governing Body. The General Body shall elect the Governing Body after every five years. All the members of general body shall have power to vote, but only the founder members shall have right to contest the election of the Governing Body.

10. Provision regarding Bank Transaction and funds of the Society -

The Society shall keep in hands the necessary amount required for day to day purpose and remaining balance shall be deposited in the name of Society in Scheduled Bank or Post Office and the Accounts shall be operated Joint Signatures of the President and Secretary or Vice-President.

11. Amendments to the Rules and Regulations -

The rules and regulations may be amended in the meeting of the Governing Body specially conveyed for that purpose, and such resolution should be passed by 2/3rd majority of the total number of the members.

12. List of Members -

List of members as required under section is of the societies Registrations 'Act' 1860 shall be maintained in the prescribed form under rule 15 of the societies Registration Rules 1971.

13. Provisions regarding amendments to the objects and amalgation -

when the object or name of the society is to be changed or the society is to be amalgated with other society the procedure laid down under section 12 and 12-A of the Societies Registration Act 1960 shall be followed.

14. Provisions regarding Resolutions

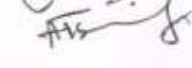
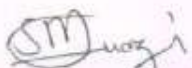
When the Society is to be dissolved then the procedure laid down under section 13 and 14 of the societies Registration Act 1860 shall be followed.

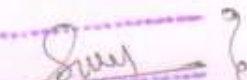

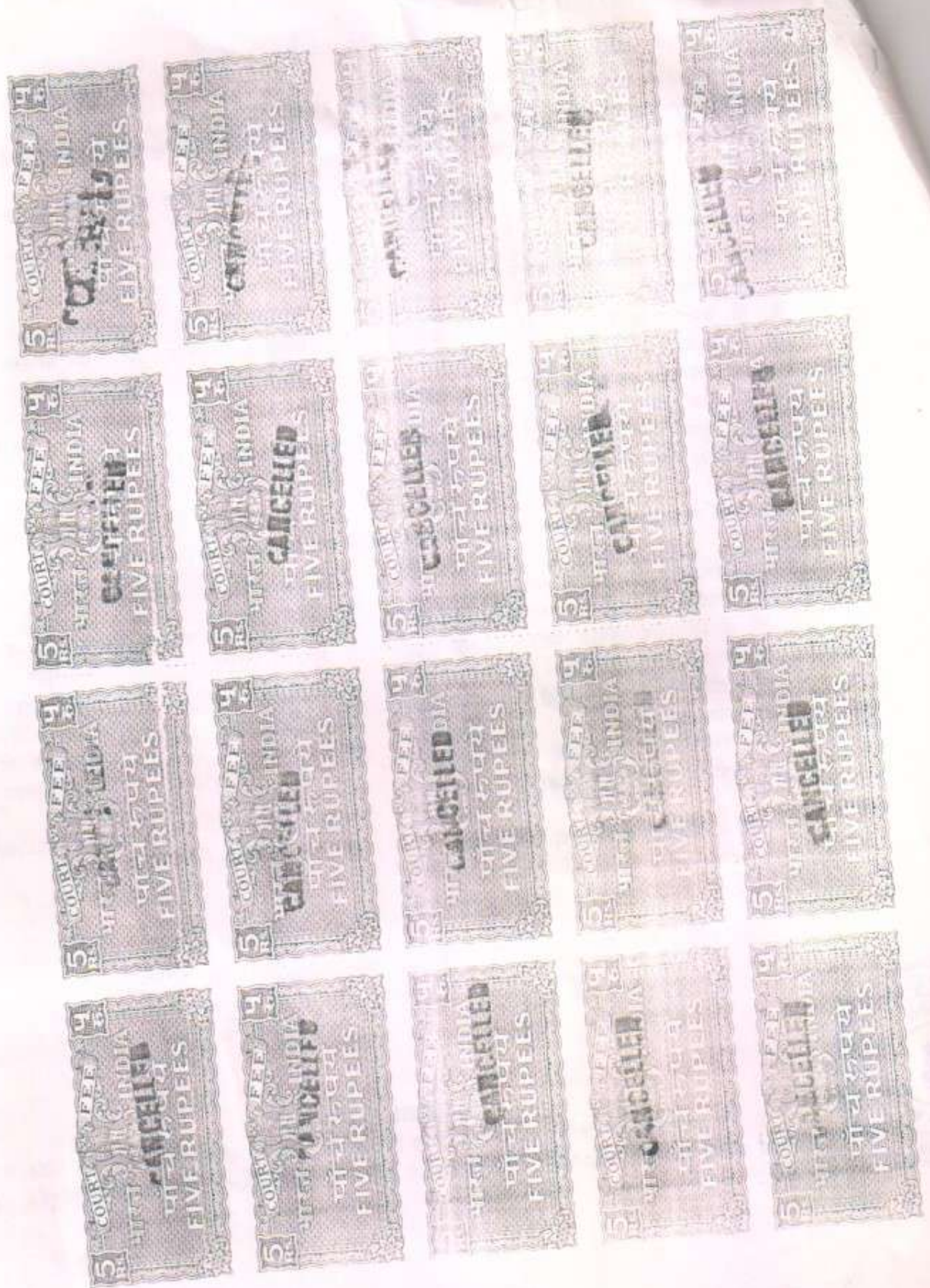
